

Dear Parents,

As you may be aware, St. George's is a G Suite school. G Suite is collection of free, web-based programs that includes document creation, shared calendars, email and collaboration tools. Many schools, school boards and school districts around the world use G Suite, because the collaborative nature, synchronistic backup and intuitive design features make it a very powerful tool in the classroom.

Your child will be provided with G Suite account. This includes an email address using our own domain (firstname.lastname@stgeorges.qc.ca). G Suite runs on an Internet domain purchased and owned by the school and is intended for educational use. Your child's teachers will be using Google Apps for lessons, assignments, and collaboration, which also means much of your child's work may be done online. Because your child is under the age of 13, we request your permission.

Student safety is our highest priority. With regard to collecting student data, G Suite is governed by US Federal laws, including COPPA: [Children's Online Privacy Protection Act](#) . COPPA applies to commercial companies and limits their ability to collect personal information from children under 13. Because Google is a commercial company (as well as an educational resource) parental consent is required.

However, **advertising is turned off in all G Suite accounts** (no matter what age), and **no personal student information is collected** for commercial purposes. This permission form allows St. George's to act as an agent for parents in the collection of information within the school context. The school's use of student information is solely for education purposes.
